6.6. The maximum number of participants is 100 vehicles.

7. The Entry Fees

- 7.1.** a) The entry fee (insurance included) is 150 € for every vehicle, except the drivers of the Mascom Cup (paying 2 300 Kč/ vehicle instead) and the drivers of the Czech Trophy of the historic cars (paying 1 500 Kč/vehicle instead)
b) The participants applied after the first closing date of the entries will pay the fee 250 € (insurance included), Kartcross 3 000 Kč and ČTHV 2 000 Kč. The organizer is obliged to issue an invoice.
- 7.2.** The entry fee will be collected during the administrative checking. No vehicle will be allowed in the competition unless the entry fee is fully paid.
- 7.4** The entry fee may be refunded only in case the competition is not taking place.
- 7.5** The entry fee can be paid in the Czech currency at the exchange rate valid for the 28th of July, 2017.

8. The Insurance

- 8.1** The AC CR has concluded the framework insurance contract No. 7721016822 on insurance of liability of the organizer for damage caused to the others in connection with a sport enterprise up to the sum of CZK 10.000.000 with the "Kooprativa pojistovna, a.s." – Vienna Insurance Group, through the company PLATINUM Consulting, s.r.o.
- 8.2** The framework insurance contract includes insurance of cars of the participants against damages caused to third persons up to the sum of CZK 10.000.000 per one insurance event with co-participation of CZK 5.000. Any damage below CZK 5.000 will be paid by the driver who caused the damage; the damages above CZK 5.000 will be paid by the insurance company without any co-participation of the insured. However, the insurance does not cover liability for the damages caused to the other participants of the event.
- 8.3** Each driver is obliged to take out the personal accident insurance, which must be presented at the administrative checking (for the FAS ACR licence holders, the license itself is sufficient). The insurance of the foreign drivers must include coverage of costs for possible medical treatment in the Czech Republic.

IV. CHECKINGS

10. Administrative Checking

- 10.1** Every driver (or his/ her representative) has to attend the administrative checking, taking place **on Saturday, the 29th of July, 2017 from 07.30 – till 11.30 o'clock (the hall at the control tower).**

11. Scrutineering

- 11.1** Every vehicle has to attend the scrutineering, taking place **on Saturday, the 29th of July, 2017 from 08.00 – till 12.00 o'clock (the hall at the control tower).**

V. RUNNING OF THE COMPETITION

13. Practice And The Drivers' Briefing

- 13.1** One free practice session should last at least 90 minutes. The free practice session is 4 laps. Every driver must participate in at least one free practice session. Each division will start individually. Every driver must finish minimum one lap of the practice session. Otherwise his/her start in the first qualifying heat must be decided by the Stewards. The Joker lap can be used during the free practice session.
The Kartcross division will run 2 official measured practice sessions, the first one according to the starting numbers while the second one in the reverse order.

- 13.2** The briefing notes for the competition in writing will be given to all drivers at the administrative checking.

14. Qualifying

There will be 4 laps in the qualifying heats. The Kartcross division does not take the Joker lap.

15. Semifinals and Finals

There will be 6 laps in the semifinal and final heats. The Kartcross division does not take the Joker lap.

16. Generally

16.6 Flag signals

If the black flag or the black flag with the orange target is shown in a heat, the driver has to go immediately to the paddock. If the same situation happens in the final heat, the driver has to go to the Parc Ferme.

VI. PARC FERME - RESULTS – PROTESTS

18. Parc Ferme

The Parc Ferme is located in the central part of the circuit. There is no Parc Ferme for the ČTHA and Kartcross divisions.

19. Results

All the results will be posted 10 minutes after every qualifying and final heat on the official notice board in the parking area.

20. Protests- appeals

20.1 All protests will be lodged in accordance with the Code. All protests must be made in writing and handed to the clerk of the course or his assistant, or in their absence any of the stewards, together with the sum of 10.000,- Kč, in cash. If the protest requires the dismantling and re-assembly of different parts of a car, the claimant must make a deposit of 250.000 Kč.

20.2 Competitors have the right to appeal, as laid down in the article 15 of the International Sporting Code. The fee is 20.000,- Kč.

VII. PRIZES AND CUPS

21. Prizes

The prize giving ceremony will be held on Sunday, the 30th of July, 2017, in the area of the control tower, immediately after the final heats. The winners of the 1st, 2nd and 3rd prizes must be present, wearing their racing suits.

VIII. FURTHER INFORMATION

22. Fire extinguishers

Each driver is responsible to make sure there is a single piece of extinguisher of min. 5 kg available within his own team's area inside the paddock.

23. Protection of the environment

Each driver is obliged to keep a plastic sheet (minimum dimensions 4 metres by 5) on the ground, under the vehicle, in the place where work on his/her car is done, in order to prevent any soil pollution in case of an accidental leak of oils or petrol, etc.

24. Others

After the arrival to the AK RAC Sedlčany circuit, every registered driver will be provided with 1+3 pieces of the identification bands with a digit code for later identification. Another bands if needed can be bought on the spot for 150 Kč for a piece. All the participants of the race are required to wear the identification bands on the arm during the whole weekend. The bands must be shown when requested by the fee collector or by the organizer of the race. If a person is caught without the band, he/ she must buy one band or will be expelled out of the racing complex.

25. Drivers' Liaison Officer

The Drivers' Liaison Officer can be identified by an orange vest with his phone number and the sign *Drivers' Liaison Officer* written on it. His photo can be found on the official notice board. He can be reached in the secretariat, in the starting area or near to the parc ferme after the finals.
